### Website

# Member Value Proposition (MVP)

### COH

The responses regarding the value of COH status to members from the member survey was not what Council had expected. Approximately 50% of the members who responded stated that COH was not of any value to them and that they would not be seeking Certification. Given that members also seek recognition of COH in legislation, we need to identify the "Gap" between value and recognition in order to create the incentive to become a Certified Occupational Hygienist.

### **AIOH House**

Having been the under-bidder at a number of auctions, a Buyers Advocate has been engaged to assist in the purchase of a suitable property / building.

### Basics Principles In Occupational Hygiene

Thanks to the Professional Development and Education Committee for the re-write of the course to meet the 2018 OHTA requirements and for those members who expressed an interest as Course Presenters. Watch for proposed dates.

## SWA Skin Exposure Guidance Note





# Congratulations Noel Tresider Awarded Member of the Order of Australia

Noel Tresider, was recently awarded Member (AM) in the General Division of the Order of Australia in the 2018 Australia Day Honours List. Noel was honoured for significant service to workplace health in the field of occupational hygiene, and to the promotion and development of standards and training.

With a long and illustrious career in worker health protection spanning 35 years, Noel is well known around the world for his outstanding leadership, pioneering vision and dedication, particularly as the co-founder and director of the Occupational Hygiene Training Association (OHTA).

He is a former AIOH President and Treasurer, a former Board Member (2015-2017) of Workplace Health Without Borders (WHWB), and a former President (2011-12) of the International Occupational Hygiene Association (IOHA). In addition to the IOHA Presidency, Noel also served as Chair of the IOHA National Accreditation Recognition (NAR) Committee for six years, and in this capacity helped to establish and lead a process to recognise excellent quality national qualification processes in occupational hygiene.

In an effort to encourage students to engage in occupational hygiene, Noel recently helped establish the Sue Davies Scholarship Fund and continues as one of its trustees. This award is granted to an International Certificate in Occupational Hygiene (ICertOH) student from a developing country to help them attend a major occupational hygiene conference. Noel's outstanding contributions to the field of occupational/industrial hygiene have previously been recognised through the IOHA Lifetime Achievement Award (2014) and the American Industrial Hygiene Association (AIHA) Yant Award (2015). ## Pam Pryor Awarded Order of Australia

Pamela Pryor has received an Order of Australia for a career of exceptional contribution to the field of health and safety, not only as a health and safety professional and through her research and academic contributions, but at the systemic level in ways which are having a long lasting impact.

Pam has overseen the development of the Body of Knowledge (BoK), which is used today as a core reference point for Australian University OHS qualifications. As the founding registrar for the Australian OHS Education Accreditation Board, Pam has been integral to a small team driving this initiative which today accredits nearly all of Australia's OHS University courses.

Pam has been one of the leaders and a co-author of the OHS professional Global capability framework project which was launched last September in Singapore, with organisations from 22 countries adopting the framework. She has also been one of the architects of the Australian WHS certification program which, now in its third year, is assisting in raising the profile of health and safety people within Australian companies.

# ANOH Conference 2017 — Exploring the Asian Way Asian Network of Occupational Hygiene Conference 2017:

The ANOH conference was held in Guang-zhou, China towards the end of December 2017 and was attended by 300 delegates from round the region plus 29 International delegates. This was the 2<sup>nd</sup> conference for the group and this year it was organised by the Guangdong Province Hospital for Occupational Disease Prevention and Treatment. Participants came from Singapore, Hong Kong, Malaysia, Taiwan, Korea, Thailand, Indonesia, Australia, New Zealand and of course China.

This year's theme was chosen due to the recent increase in demand for occupational hygiene in the Asian region, although it has not yet been fully developed in most of these countries. It looked at the traditional scientific, technical knowledge and skills needed and also at the capacity for communication and implementation based on social/culture circumstances and context. These latter issues are needed to continuously discover novel opportunities, alternatives and exceptional approached that might fit the Asian society.

A number of senior speakers from China presented as well as a number of International guests. One keynote speaker was Jiang Xiaopeng, the Chinese WHO representative, who spoke about the latest information for our region "An outlook of occupational health – From an International and

Regional Perspective". This looked at the latest information from Who and then at the situation for the ANOH area which covers 37 countries and 1.8 billion people. He also discussed the 5 strategic objectives from WHO on occupational health:

- 1. Devise national policy instruments;
- 2. Protect and promote health at the workplace;
- 3. Improve occupational health services;
- 4. Provide evidence for preventive action; and
- 5. Address workers' health in all policies.

A large body of the conference was given over to talks about GHS and OEL's from a number of countries which culminated in a panel discussion on the "Development of ANOH Occupational Exposure Limits", or in other words, is there a need for an Asian OEL separate of the ACGIH etc systems. This was an interesting discussion and one that a working group will now explore.

Preceding the conference, an ANOH Board meeting was held at the Guangdong Province Hospital for Occupational Disease Prevention and Treatment (GDHOD). At this meeting it was agreed to establish three working groups on the following areas:

- 1. ANOH-OEL's,
- 2. Asian OH country profiles; and
- 3. Provision of OHS training in Asia.

If anyone is interested in serving on these working groups please contact the AIOH Office so that we can put your name forward. You do not need to be a member of ANOH to participate in these working groups.

It was also agreed that the 3<sup>rd</sup> ANOH conference will be held in Taipei, Taiwan in October 2018 and that a further meeting will be held in Yeosu, South Korea.

Following the Board meeting a technical tour of the GDHOD was conducted by Dr Qu. This was then followed by a meal at the Fisher's Village, which was interesting and held in a magnificent room downtown.

# Korean Industrial Hygiene Association Winter Conference January 2018

Through our Memorandum of Understanding, I was invited to attend the KIHA 2018 Winter Conference which was held in Yeosu City, South Korea in January 2018.

Also representing the AIOH, and the IOHA Board, was Mr Philip Hibbs (Immediate Past President, AIOH).

The International Contingent comprised representatives from Malaysia, Australia, South Africa and Myanmar. The presentations in the International Session included:

- The significance of Co-operation in Industrial Hygiene
- International Co-operation on IH issues with Malaysia
- International Co-operation issues with Myanmar
- International Co-operation and Development Strategy in IH by Korean Occupational Safety
   Health Agency.

These presentations were certainly enlightening, particularly the collaborative project of MOLISA and KOSHA to refurbish the Vietnamese Occupational Safety & Health Training facility near Hanoi. This project was funded through the Korean Government (KOICA) to a value of approximately US3.4 million dollars.

Ongoing and future projects for the protection of worker health proposed by the ILO and WHO in the Asian region were also discussed.

Informal discussions were also held with Peter-John Jacobs (Jakes) President Elect IOHA / past IOHA NAR Committee Secretary / Registrar, and Dr Dooyong Park President of ANOH and IOHA Executive member, regarding mutual recognition and reciprocity of IOHA NAR schemes. This discussion is gaining momentum and will be raised at the IOHA Board meeting in Dublin, May 2018. This is becoming even more important as the research shows there are insufficient trained Occupational Hygienists to meet the required demand throughout the world.

Highlights for the International Guests were the Industrial site tour of Yeosu City, which has very large underground oil storage (installed following the oil crisis), large refining capacity, port facilities and major manufacturing facilities, and the Technical Tour to the Korea Occupational Safety & Health Agency (KOSHA) facilities in Ulsan http://english.kosha.or.kr/english/main.do (http://english.kosha.or.kr/english/main.do)

KOHSA publish a quarterly peer reviewed journal in English SH@W (Safety and Health at Work). This journal publishes articles on occupational epidemiology, medicine, hygiene, toxicology, nursing and health services, work safety, ergonomics, work organisation, engineering of safety, safety management and policy http://www.e-shaw.net/ (http://www.e-shaw.net/)

Specifically I acknowledge Professor Kim, Ki-Jin (President KIHA), Dr Doo Yong Park (President KOSHA), Haesong Kwon and Seul Kee Yang for their hospitality and managing all travel arrangements.

All domestic expenses within Korea were generously covered by KIHA.

AIOH Mentoring Program - hear first hand from a Mentee

My name is Marcella Donnellan. I have been an AIOH member since 2012 and have been part of the AIOH mentoring program since 2017. Presently, I am on assignment in the US, in an Occupational Hygiene role.

I believe it is everyone's responsibility to be a leader and I continually work hard at improving myself.

I requested a mentor as part of my development goal of reaching COH in the future. In addition to reaching COH, I also felt it was a great program to expand and refine my technical and leadership skills under the guidance of a COH.

At first, I was a confused on the structure of the mentoring program. As a past mentee in a Government mentoring program, I was expecting the AIOH program to have a similar structure. That is - short and long-term goal setting, with recurrent meetings to discuss progress.

The AIOH's structure is different. It is more informal. Your assigned mentor is there for you to contact when you need technical help, faced with challenging situations in your workplace, and when you need neutral advice regarding career development opportunities.

While being in the program, I was faced with a career crossroads situation. I needed impartial advice and the mentor was the 'go to person for me'. They helped me figure out what I needed to do and I was confident about my decision.

I also found if the mentor feels they are not the more 'experienced' person to give you advice, they ensure you are given access to the right contact to talk to. This in turn expands your networking groups.

For me, I am enjoying my involvement in the program and would highly recommend it to other AIOH members who wish to become future Certified Occupational Hygienists.

# National Update

# Special General Meeting to amend the AIOH Rules and Statement of Purpose

The AIOH was incorporated in Victoria under the Associations Incorporation Act 1981 on 05 December 1988. This legislation has been replaced by the Associations Incorporation Reform Act 2012 and associated regulations. Changes to the Associations Incorporation Reform Regulations 2012 will require changes to the AIOH Rules and Statement of Purpose (**Rules**) to ensure we remain compliant.

Probably the most significant change is to the voting rights of members. The Associations Incorporation Reform Regulations 2012 – Schedule 4 Model Rules for an Incorporated Association Rule 13(2) specify the voting rights of members:

A member is entitled to vote if-

- the member is a member other than an associate member; and
- more than 10 business days have passed since he or she became a member of the Association; and
- the member's membership rights are not suspended for any reason.

The current AIOH membership structure is described in Section 6.1 of the AIOH Rules and shown graphically in the following diagram.

Under our current Rules, only Full Members and Fellows have voting rights. Provisional Members are unable to vote, which is no longer not compliant with the Model Rules of Associations Incorporation Reform legislation. The review of the AIOH Rules is currently being conducted by the Council and the Special Advisory Committee (SAC). A gap analysis is being prepared to identify the areas of non-compliance. This will be followed by redrafting and amendments to the AIOH Rules to bring it into compliance with the legislation. These amendments will need to be approved by a Special General Meeting, to be organised later this year.

An option under consideration is to roll the Provisional Member grade into Full Member. The requirements for Full Member (currently Rule 6.2.1) would not change. Rule 6.2.1(c) requires applicants for Full Member to have worked for more than five years in a professional capacity in the field of occupational hygiene or one of its specialist branches. Under the proposed change, those Provisional Members with more than 5 years' experience would be grandfathered into the Full Member grade. Provisional Members with less than 5 years' experience would be grandfathered into Full Member after achieving the required five years of experience. If this model is adopted, eventually there would be no Provisional Member grade. In the interim, Provisional Members will be granted voting rights.

### In Memorium

### Steven Kee

The AIOH is saddened to advise members of the unexpected passing of our longstanding and energetic member, colleague, and friend, Steven Kee on 3 January 2018.

Steven was a Fellow of the AIOH, a Certified Industrial Hygienist with the ABIH (admitted 07 December 1992) and a Certified Occupational Hygienist (COH)<sup>®</sup> with the AIOH (grandfathered December 2004). He was an active member of the AIOH for 30+ years and contributed some 15

papers at AIOH conferences. Steven also presented at the 2012 IOHA Conference in Kuala Lumpur and 2015 IOHA conference in London.

Steven held the following academic qualifications (i) Bachelor of Applied Science (Env. Health) from Curtin University (awarded in 1978), (ii) Graduate Diploma of Occupational Hygiene from Deakin University (awarded in 1989); (iii) Graduate Diploma of Occupational Hazard Management from Ballarat University College (awarded in 1991) and (iv) Graduate Diploma in Environmental Science from Monash University. Steven joined the AIOH as an Associate Member in July 1987. He was granted Full Membership in August 1993 and made a Fellow of the Institute in 2013.

Steven was well liked amongst the Australian occupational hygiene community as an energetic, thoughtful, intelligent contributor to the many and varied activities in which he became involved over his long and distinguished career. A regular at AIOH events, he was always well informed and knowledgeable on the issues in play and approachable and generous with his time to those interested in furthering the discussion. He remained committed to our scientific and ethical principles throughout his career.

Steven worked as an occupational hygienist across a varied range of resource industries and companies including oil, various commodity minerals, and associated mining and exploration, both surface and underground, smelting and refining in Australia and overseas. His other experience included aviation, marine, shipbuilding, commercial diving, manufacturing, major construction and major demolition.

Tracey Bence in reflecting on her association with Steven provided the following comments:

- 1. Contributor to the COH Examination Board since its inception in 2004
- 2. Long standing and enthusiastic member of WA chapter of AIOH, regular attendee at meetings since early 2000s
- 3. Strong contributor to Membership & Qualifications committee reflecting his enthusiasm for progression of new hygienist and the hygiene profession
- 4. Well known for his strong intellect, and technical and scientific capability.

Steve worked in various roles across several States and Territories. In the early 1990's he was working for Shell at the Geelong refinery. He then moved to Western Australia in 1995 with Rio Tinto before relocating to Darwin in 1997 – 2000. He had by then started his own consultancy company OccDev which he continued to work under until his passing in Mount Isa earlier this year.

In closing, I have included some thoughts from Jeremy Trotman as it sums up Steven well.

"I did not work with Steve and had not seen him in many years other than catching up at AIOH Conferences, but can clearly remember him from those events, the early days when we studied for the ABIH CIH along with Georgia Sinclair, Sonny Maher and a few others and several trips to Mount Hotham skiing. The memory is of a highly intelligent, energetic contributor to the Occupational Hygiene field and the many other intellectual and sporting activities in which he involved himself. A keen commentator, at our conferences, well informed and ready to provide comment, critical or otherwise and always constructive. Never in my experience was a destructive

element detectable in his enthusiastic input and he was always very approachable, generous with his time and more than happy to continue discussions with anyone of a similar bent. The little I knew of his sporting life seemed to mirror his occupational hygiene activities in energy levels and commitment. On one occasion he woke up the lodge, arriving at three thirty in the morning, only to be up the same morning at seven and out at eight in below freezing temperatures and gale force winds to beat the non-existent crowds. With his passing we lose an intelligent and committed hygienist and genuinely nice guy. Jeremy Trotman."

He was a most remarkable bloke and his passing is a big loss to the Institute and our profession.

Steve is survived by his wife Fiona and two daughters Madeleine and Elizabeth.

Our thoughts are with his family and friends.

# HOWARD L. KUSNETZ (1929 - 2017)

Our colleague, and inaugural AIOH Honorary Fellow, Howard L. Kusnetz, CIH (Ret.), CSP (Ret.), passed away on 21 December 2017.

Howard had a long and distinguished career in industrial hygiene. Having gained his B.A. in English Literature, a B.S.E in Chemical Engineering and M.Sc. in Industrial Hygiene from Columbia University he commenced his career as a research chemist with Geigy Company then moved to the US Public Health Service in 1951 undertaking a large and varied range of field assignments.

These included exposure monitoring and control of radon daughters in Colorado uranium mines and mills where he developed the Kusnetz Factor to correct for the number of atomic disintegrations between sample collection and the midpoint of alpha particle counting, two stints at the atomic bomb tests in Nevada, and hazard identification and control on nuclear submarines. He was a major part of the team that authored the Occupational Safety and Health Act of 1970 and the subsequent creation of OSHA and NIOSH.

He rose to the position of Assistant Director of NIOSH and held the rank of Captain as a Commissioned Officer in the United States Public Health Service (USPHS). Having spent 20 years in government service he then took up the position of Manager, Industrial Hygiene with the Shell Oil Company based in Houston and was later promoted to Manager, Safety and Health, Manufacturing.

He was an avid communicator, educator and had a primary interest in developing young professionals as such he published widely and held the positions of Professor and Visiting Lecturer in nine separate Universities, and was on numerous international committees particularly with ILO in Geneva. Howard had a passion for contributing to the development of industrial hygiene and contributed to ACGIH, served on the Board and then as Secretary of ABIH for 7 years, and on numerous committees of AIHA from 1961 through to 1986 when he was President.

Howard Introduced the first certification program to Australian hygienists, the ABIH, before the AIOH established their own program He first came to Australia in 1982 at that time he was Secretary of the ABIH and was to Proctor the first CIH examination held the weekend prior to the first AIOH Conference held at Melbourne University. Whilst 14 then young hygienists sweated out the four 3 hour certification examinations, Howard caught up on Australian culture by reading the rules of cricket. This was the beginning of a long professional and personal friendship with many in the Australian profession.

He openly shared his breadth of experiences with us, and many will remember him relating his numerous adventures. In particular monitoring exposures during the atomic bomb testing program in Nevada during the 1950's, where he was involved in measuring the level of radiation at ground level which he did by holding a Geiger tube out the window of a Dodge sedan as they drove across the desert chasing the fall out cloud. Another involved the problems associated with addressing the government brief of assessing the personal radiation fallout on all major occupational groups in Nevada, even though the second largest occupation in the area was known to be prostitution.

The AIHA Kusnetz Award was established 1987 to honour a certified hygienist under 40 years of age who is currently employed in the private sector and who by exhibiting high ethical standards and technical abilities has provided for the highest standards of health and safety protection for employees for whom he or she is responsible; and who shows promise of leadership in the industrial hygiene profession. There have been many winners who went onto be successful leaders in occupational hygiene with the first awardee becoming the Director of OSHA.

Howard was the central American figure involved in forging links between ABIH, AIHA and the AIOH, including being part of a group presenting the case for the AIOH to be the first group outside the USA to independently run the ABIH certification examination. He was also instrumental in nominating and promoting Trevor Jones in 1988 as the first Australian AIHA Yant Awardee, and also in subsequent years four other Australian Yant Award recipients. The initial Yant Award lead to discussions with the local group of MSA for the sponsorship of the first AIOH member development award in the form of the MSA Scholarship for postgraduate study in occupational hygiene (now the AES Postgraduate Scholarship) and a later Yant Award lead to the sponsorship of the AIOH Draeger Professional Development Award.

In 1990 Howard was granted AIOH's first Honorary Fellow and continued to share an interest in the AIOH and its members right up until his final days. Over the years Howard and Florence together have generously and warmly invited all Aussie attendees at an AIHA conference, to the 'A Team - Kusnetz Dinner'. This became a tradition that has made Aussie delegates not only feel personally welcome at the AIHA's huge event , but forged lasting personal and international friendships.

Howard was more than just a colleague, he was an inspirational mentor touching many in both their professional and personal life by sharing a simple but effective approach to life, friends, the profession and community as well as to his religion. Howard is survived by Florence his loving wife of 67 years and a large three generational family in the USA and Israel.

# AIOH Exposure Standards Committee Report by Ian Firth

The AIOH Exposure Standards Committee has responded to a request from SafeWork Australia to peer review their draft position paper on criteria for assignment of a skin notation in Australia and their Skin Notation Calculator. The aim of the draft document was to establish clear criteria for the assignment of a skin notation in Australia, in general being consistent with those used by most international standard setting agencies.

NATA is in the process of withdrawing technical documentation regarding procedures and frequency for calibration of field and laboratory equipment used for occupational hygiene assessments and analysis. These documents were developed by experienced AIOH members as part of their role on the previous NATA Occupational Hygiene Technical Committee. The technical content of the documents along with copyright is being handed over to the AIOH, to be published as Technical Papers.

The information included in the Technical Papers attempts to provide practical and pertinent information to assist Occupational Hygienists or laboratory personnel to use correct sampling or analytical techniques and equipment for collecting valid samples, which can be used to compare against the relevant workplace exposure standards (WES) where personal sampling has been conducted.

The committee, with major input from Linda Apthorpe, has re-drafted three papers for approval by Council:

- Air sampling pumps equipment and calibration requirements.
- Flow measuring equipment: calibration requirements.
- Asbestos analytical equipment: calibration requirements.

# Reclassification of Welding Fume as Carcinogenic - from an Australian Perspective

AWS recently wrote a follow-up White Paper on the recent "reclassification of welding fume as carcinogenic", from an Australian perspective pulling relevant information from multiple sources into one easy to read 12 page document. This was so that Australian employers of welders and welders themselves can make better decisions regarding welding fume and suitable respiratory protective measures.

The paper also attempts to raise awareness of workplace cancer risks associated with welding so that welders question and challenge whether they are suitably protected even when operating under the current Australian workplace exposure standards for welding fume.

# Queensland Member Survey Results

Thank you fellow Queenslanders for your input on the State Chapter meetings. A total of 23 responses were returned. Your feedback included requests for sessions on new sampling & analytical techniques, ethics, COH practice exams, case studies of interesting or difficult issues that other members have experienced, highlights of the conference as well as sessions on the old stalwarts of dust, mould, asbestos, heat stress, mould, noise, vibration and mould (actually mould seemed prevalent and invasive, infesting the survey results).

One respondent also suggested replicating the WA Chapter session (A Brief History of Poisons) and as I had the pleasure of attending the WA Chapter meeting in Perth this week, I'm inclined to agree. Hats off to our Sandgroper colleagues; Barry Chesson and his team have set a high bar indeed.

In terms of incentives to increase attendance, suggestions included beers and bringing a non-member for free. Venue preference was a mixed bag (not unlike our recent state election results) with office (34%), other (unspecified - thanks for that) at 28% and pub (a surprisingly low 14%) leading the categories. The majority of respondents (48%) indicated a preference for sessions to be held after work with 'lunch & learn sessions' (24%) and breakfast at 19%. General consensus (69%) was held on a session run time of 1 to 2 hours including networking with a spread of 30 mins to 5 hours (someone really loves their hygiene!). No clear preference was held on days of the week but as a group, we are unanimously protective of our weekends.

For those living outside of Brisbane (28%) and given the tyranny of distance in our great state, 52% of respondents have also asked for increased use of virtual sessions to access technical content when they can't physical make it. This is something that we have trialed previously but will work on.
